

“What in the World is going on?”

*The War against Men* by Dr. Richard T. Hise

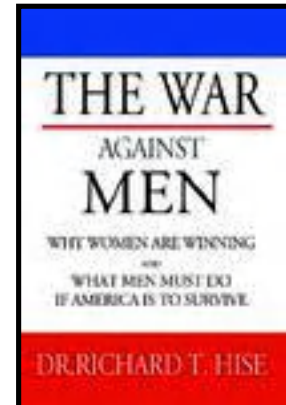
In his growing discovery of the war against in men, Dr. Hise suggest and outlays a “plan of action”; both personal and political in its determination, the plan must begin on the understanding that men are the minority in our country – and should invoke the “minority card” – or the 14<sup>th</sup> Amendment, the equal protection clause.

A measure of this kind would – in his view:

- Regain lost rights...and *level the playing field* in all sectors.
- Stop the *sliding* at present in the second-class status o society

In keeping with the plan is a proposed *propaganda machine* that:

- Rebuts the lies and unfair and prejudiced comments
- Extols the virtues of men (and boys) in our society



### Why is this so-called war so important to our society?

Dr. Hise describes the evidence of history that *bears-out* how nations erode and die from within. On this understanding is the general understanding of our culture and society – the views, opinions, preferences, and other points that comprise public opinion and sentiment. Whereas our society if vividly aware of the threat (and some actual occurrences) of terrorism, it is far less aware of the issues and trends that emanate from within our ranks.

A much respected author, Paul Roberts (*The Tyranny of Good Intentions*), is cited as assessing the transformation of feminism from a movement of equality that has escalated to *gender warfare* against masculinity. Another author who has noted a similar assessment is Warren Farrell (*The Father and Child Reunion*).

On concern for both the veracity and validity of his research, Dr. Hise notes that similar attention to details has not been applied among the anti-male movements. He writes: “To put in bluntly...they have lied.” Some examples of this falsification of data and reporting are:

- Dr. Bernard Nathanson – a leading proponent of legalized abortion – admitted after his departure and Christian conversion that false data was used to drive *Roe versus Wade*.
- Similar personal lies were later confirmed by one of the two initiators, Norma McCorvey (“Roe”).

But the list of erroneous and misleading does not stop with legalized abortion; as other women’s issues have been profiled in a similar vein of careless and purposeful calculation. **The motives are grounded in the basic difference between perception and reality** – where both repetition and rhetoric can spur the effort – regardless of the truth or accuracy of the actual data and related facts.

Dr. Hise makes clear his purpose for writing the book:

This book is written for men – a book to inform and energize us and, yes, to uplift us and extol our accomplishments.

In this purpose, he does not discount the possibility of mixed reaction and interests; after all, some men are perhaps *on top of their game* – and may not yet recognize the movement and shifting of society. Then again, even if are aware, they may not care...

Yet, this is a book that both presents the problems and offers a plan of action. Let’s just say that this person evidently cares (about men and their value to society) and is so concerned about the matter that he has invested much time and effort into the research and reporting.
